**KFC Bucket Moments Competition**  
**Terms and Conditions**

**By entering “KFC Bucket Moments Competition”  
 (“the Competition”), you are agreeing to the following Terms and Conditions:**

**1. STANDARD TERMS**

1.1 Information on how to enter the Competition forms part of these terms and conditions (“Terms and Conditions”). Participation in this Competition is deemed acceptance of these Terms and Conditions.

**2. WHO CAN ENTER?**

2.1 Subject to clause 2.2 and 2.3, entry is open to all residents of Australia aged 14 or older, where the Channel Seven, and affiliate broadcaster, signal is received.

2.2 Entrants aged over 14 but under 18 years old must have parental/guardian approval to enter and the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Competition.

2.3 Employees, and immediate family members of employees of Seven Network (Operations) Limited, Kentucky Fried Chicken (KFC) Pty Ltd, Ansible Pty Ltd, and their associated agencies and companies are not eligible to enter the Competition. For the purpose of this clause, immediate family member means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

**3. HOW TO ENTER**

3.1 The Competition commences on **Thursday 7th December 2023 at 09:00 AEDT** and closes on **Wednesday 24<sup>th</sup> January 2024 at 09:00 AEDT** (“the Competition Period”).

3.2 The Competition will be advertised on, but not limited to, the Seven Network (“the Network”) during the Big Bash League and Cricket Test Matches (“the Programs”), [www.7plus.com.au](http://www.7plus.com.au), and supporting promotional media throughout the Competition Period to provide details on how to enter the Competition.

3.3 **COMPETITION ENTRY:** In order to enter the Competition, entrants must complete the following steps during the Competition Period:

a. Head to the promotional hub at <https://bucket.7sport.com.au>; and

- b. Watch the two (2) featured “Moments” and vote for their favourite Moment; and
  - c. Complete all required fields in the Competition entry form.
- 3.4 For clarity, “Moments” refer to a variety of archival moments in Cricket over the decades, which will be featured on the promotional website for entrants to vote upon. Choice of “Moment” has no bearing on whether an entrant will be eligible to win a Prize.
- 3.5 Entries that meet the requirements of clauses 3.3 and adhere to these Terms and Conditions will be deemed a Valid Entry (“Valid Entry”). All Valid Entries will be entered into the Major Prize Draw and the relevant Minor Prize Draws corresponding to the Entry Period in which they are submitted. See clause 6.7 for more detail on the Competition Prize Draws.
- 3.6 For clarity, if the user completes steps 3.3 a) and 3.3 b) but does not complete step 3.3 c), their vote will be counted however they will not be entered into any corresponding prize draws.
- 3.7 Entries are limited to one (1) Valid Entry per person per day throughout the Competition Period.
- 3.8 Incomplete or indecipherable entries will be deemed invalid.
- 3.9 The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

- 4.5 The total maximum prize pool value for the Competition is **\$21,000.00 (including GST)**. Prize value is correct as at the date of printing. The Promoter accepts no responsibility for change in Prize value between now and the ultimate date on which the Prize/s is awarded.
- 4.6 Prize/s are not transferable, exchangeable, and cannot be taken as cash, unless otherwise advised.

- 4.16 The Promoter reserves the right, at any time including but not limited to after Winner's have been published, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process including but not limited to engaging in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Competition. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

### **CASH PRIZE**

#### **(APPLICABLE FOR MAJOR AND CASH MINOR PRIZE ONLY)**

- 5.1 Cash Prizes will be transferred via EFT to the Winners' nominated bank accounts. The Prize value awarded is in Australian dollars. It is the responsibility of the Winner to ensure the bank account and details provided are correct. The Promoter and Ansible Pty Ltd are not responsible nor liable for a prize that is lost in transit due to the Winner providing incorrect details.
- 5.2 Subject to clause 6.10, Cash Prizes will be fulfilled within twenty (20) working days of Ansible Pty Ltd receiving all required forms and details from each Winner.

### **KFC VOUCHER**

#### **(APPLICABLE FOR VOUCHER MINOR ONLY)**

- 5.3 KFC Vouchers will be sent via mail and must be redeemed in full and in-store when placing an order. The vouchers will expire on **Tuesday 3<sup>rd</sup> February 2026** and will not be valid from this date. Any ancillary costs associated with redeeming a KFC Voucher are not included. Any unused balance of a KFC Voucher will be forfeited, and no change will be given. Redemption of a KFC Voucher is subject to any terms and conditions of the issuer including those specified on the KFC Voucher.
- 5.4 The Promoter and Ansible Pty Ltd is not responsible nor liable for a prize that is lost in transit due to the Winner providing incorrect details.
- 5.5 Subject to clause 6.10, KFC Vouchers will be posted within ten (10) business days of Winners confirming their delivery address to Ansible Pty Ltd. Items will be posted via express, registered post.

- 6.3 The Major Prize Draw will draw one (1) Winner from all Valid Entries received during the Competition Period.
- 6.4 The Cash Minor Prize Draws will each draw one (1) Winner from all Valid Entries received during the corresponding Entry Period. Entry Periods are stipulated in clause 3.1.

- 6.8 All Prize Draws will be conducted at Komo Technologies, 383 George St, Sydney NSW 2000.
- 6.9 Winners will be notified via e-mail and phone call from Ansible Pty Ltd on behalf of the Promoter within seven (7) working days of the corresponding Prize Draw.
- 6.10 Once the Prize is accepted, Winners must deal directly with Ansible Pty Ltd to organise Prize fulfillment.
